The existing property is a mid terrace double fronted two storey traditional masonry walls and slate pitched roof building. Its planning history is that 'Planning Permission was granted in September 1985 for the Change of Use of the above property from use as a shop to a café/restaurant' (permitted Development from A1 to A3). However that consent was only half implemented as one half of the property was retained as a shop, with the other half being a café, and that half has since been changed from A3 to A2.
